After a two-and-a-half-month summer break the members of the Ohio General Assembly were back to work in their offices, committee rooms and chambers. The next three months will be a rush to move bills through the legislative process. While it is not as pressing as a lame duck the legislators seem to like to end the year in a productive manner.

Top priorities for the moment are still the same –property tax relief, redistricting, and overriding the 67 items vetoed by the governor in House Bill 96 (the appropriations bill).

In the month of September, members of the House dropped four bills and four resolutions pertaining to veterans and/or the military. Senators dropped one of each. The new legislation is listed beginning on page six.

Hearings Held for Veteran/Military Legislation

September 15-19

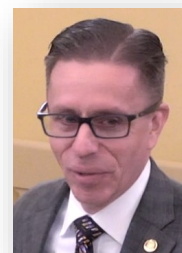
There was only one bill slated for a hearing this week. Amended Senate Bill 17 was on the agenda of the House General Government Committee on Tuesday afternoon. It was the 3rd hearing for the bill that would designate March 9th every year in Ohio as "6888th Central Postal Directory Battalion Day." There was no testimony given. The bill was introduced in January by Senators **Michele Reynolds** (SD-3) and **Hearcel F. Craig** (SD-15). In February the Senate, with a 32 to 0 vote, passed the amended bill.

September 22-26

On Wednesday, the House Veterans and Military Development Committee held the only hearing of the week. There were four concurrent resolutions on the agenda. All were introduced on September 15, and it was their first hearings.

The first sponsor testimony was from Representative **Michael D. Dovilla** (HD-17) for HCR 20 which will honor the distinguished service and exceptional valor of the men and women of the United States Navy and commemorate the 250th anniversary of its founding. His cosponsor, Representative **Nick Santucci** (HD-64) was unable to attend the hearing but submitted written testimony for the committee members.

Next on the agenda was HCR 18 sponsored by Representatives

A look at what the bills say... *In a Nut Shell*

Summaries from the OFFICE OF RESEARCH AND DRAFTING

Currently there are two bills, both in the House, that would amend the Ohio Revised Code dealing with 'specialty license plates'.

One (HB 339) will allow the existing "Purple Heart" license plate to be purchased by surviving spouses of veterans who were awarded Purple Heart Medals.

The other (HB 419) will create a new specialty license plate to raise fund for the organization known as Save22.

House Bill 339—To amend section 4503.571 of the Revised Code to allow the surviving spouse of a Purple Heart recipient to retain or obtain the "Purple Heart" specialty license plate.

The Analysis

"Purple Heart" license plate

The bill allows the surviving spouse of a Purple Heart recipient to retain or obtain the "Purple Heart" license plate if the spouse has not remarried and if the deceased recipient was issued or was eligible for the "Purple Heart" license plate. Currently, the surviving spouse of a Purple Heart recipient cannot apply to obtain or retain the license plate. Under current law, when the ownership of a motor vehicle is transferred after the owner's death, the Registrar of Motor Vehicles must replace the "Purple Heart" license plate with a non-Purple Heart license plate.

Under the bill, in order to retain or obtain the "Purple Heart" license plate, a surviving spouse must apply to the Registrar. The surviving spouse must include with the application documentary evidence of the deceased person's Purple Heart award and any other evidence the Registrar requires. The surviving spouse may retain or obtain the license plate upon payment of the required regular registration taxes and fees and compliance with all applicable laws relating

House Bill 419—To amend section 4501.21 and to enact section 4503.727 of the Revised Code to create the "Save22" license plate.

The Analysis

License Plate

Save22 license plate, which must display an appropriate logo and words selected by the representatives of Save22 and approved by the Registrar of Motor Vehicles.

Recipients

Available to all applicants.

Eligible Vehicles

Any passenger car, noncommercial motor vehicle, recreational vehicle, or other vehicle approved by the Registrar.

Contribution;

Additional BMV Fee;

Use of Contribution

\$22 required contribution.

\$10 additional administrative BMV fee.

Contributions must be paid to Save22, which must use the contributions for any purpose it determines to be necessary.

Requirements for Issuance

1. Submission of an application;
2. Payment of the regular license tax, any local tax, contribution, administrative fee, any special reserved license plate fee if necessary; and
3. Compliance with all other relevant laws relating to motor vehicle registration.

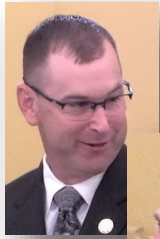

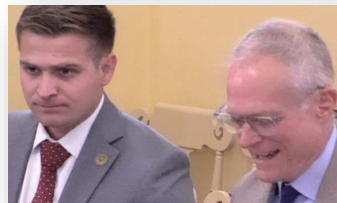
The resolution

Committee Changers

September 9

Speaker of the House **Matt Huffman** (HD-78) announced the removal of Representative **Nick Santucci** (HD-64) from the Rules and Reference Committee and the appointment of Representative **Brian Stewart** (HD-12) in his place. Stewart is an infantry veteran of the Iraq War.

September 15

Speaker Huffman announce that he appointed the following representatives to the Joint Committee on Congressional Redistricting: **Adam C. Bird as Co-Chair, Nick Santucci, Brian Stewart, D.J. Swearingen, Dani Isaacsohn, and Desiree Tims**. The only veteran is Stewart.

September 18

Senate President, **Rob McColley** (SD-1) announced the appointment of the following senators to the Joint Committee on Congressional Redistricting: **Jane M. Timken as Co-Chair, and Theresa Gavarone, Stephen A. Huffman, Bill Reineke, Nickie J. Antonio, and Willis E. Blackshear, Jr.** as committee members.

September 17

Speaker Huffman made changes to a dozen House Standing Committees. The following affected the legislators who are Veteran:

In the Veterans and Military Development Committee. Representative **Derrick Hall** (HD-34) was removed as Ranking Member and Representative **Meredith R. Lawson-Rowe** (HD-5) was designated as the new Ranking Member. Hall serves as a Judge Advocate General (JAG) officer in the Army Reserve. Lawson-Rowe is not a veteran.

In the House Insurance Committee the speaker removed Representative Tims and appointed Hall as to the committee and Ranking Member.

In the Ways and Means Committee Representative Hall was removed and Representative **Chris Glassburn** (HD-15) was appointed. Glassburn is not a veteran.

September 23

The following changes to the committee on Rules and Reference by Speaker Huffman: Removed Representative Stewart; appointed Representative Santucci.

PRIMARY ELECTION DAY

Tuesday, November 4th

Oct. 06: Deadline for voter registration for Nov. 4 general election (30 days before general election)

Oct. 07: Early in-person absentee voting begins (first day after close of voter registration)

Oct. 28: Applications for absentee ballots to be mailed for Nov. 4 general election must be received by boards of elections by the close of business (7 days before general election)

Nov. 04: General Election Day. -Polls open from 6:30 a.m. to 7:30 p.m.

Absentee ballots, returned in person or via a method other than U.S. Mail, must be received by the boards of elections by close of polls

LEGISLATION INTRODUCED IN SEPTEMBER

SB 253 introduced on September 3 by Senators **Hearcel F. Craig** (SD-15) and **Michele Reynolds** (SD-3).

The bill would enact section 5.213 of the Revised Code to designate February 20th as "Black Ohioan Civil War Medal of Honor Recipient Day."

It has not been referred to a committee yet.

HB 434 introduced on September 3 by Representatives **Bernard Willis** (HD-74) and **Brian Lampton** (HD-70).

The bill would amend section 4507.21 of the Revised Code to exempt certain military-related limited term driver's license applicants from the driver's education requirements and to declare an emergency.

It was referred to the House Transportation Committee.

HB 451 introduced on September 15 by Representatives **Meredith R. Lawson-Rowe** (HD-5) and **Jeff LaRe** (HD-73).

The bill would enact section 5534.931 of the Revised Code to designate a portion of Interstate 70 in Franklin and Fairfield counties as the "CPL Lindsey William Mitchell Memorial Highway."

It has not been referred to a committee yet.

HB 452 introduced on September 15 by Representatives **Cecil Thomas** (HD-25) and **Meredith R. Lawson-Rowe** (HD-5)

The bill would enact section 5.2322 of the Revised Code to designate October 1st as "761st Tank Battalion Day."

It has not been referred to a committee yet.

HCR 18 introduced on September 15 by Representatives **Ty D. Mathews** (HD-83) and **Kevin D. Miller** (HD-69).

The concurrent resolution would urge Congress to recognize United States troops who served in Honduras from 1981 to 1992.

It was referred to the House Veterans and Military Development Committee.

HCR 20 introduced on September 15 by Representatives **Michael D. Dovilla** (HD-17) and **Nick Santucci** (HD-64).

The concurrent resolution would honor the distinguished service and exceptional valor of the men and women of the United States Navy and to commemorate the 250th anniversary of its founding.

It was referred to the House Veterans and Military Development Committee.

SR 192 introduced on September 17 by Senator **Andrew O. Brenner** (SD-19).

The resolution would recognize Rutherford B. Hayes Day in Ohio October 4, 2025.

It was adopted the same day it was introduced.

A bill is a document by which a member of the General Assembly proposes to enact a new law or amend or repeal an existing law. The term "bill" is used to refer to the document from the time it is drafted and delivered to the members until it is considered and approved by both the House and the Senate. After passing both houses, a bill becomes an "act" and must be presented to the Governor for acceptance or rejection. If accepted, or if the Governor does not take any action for ten days, it becomes a "law."

An idea for a new law or a change in an existing law might originate with a member of the General Assembly, an administrative agency of the state, the Governor, a special interest group, or a private citizen.
