National President's Visit





Eligibility Requirements for VFW Auxiliary Membership:

Members must be at least 16 years old.

Those eligible are:

- Husband/Wife
- Widower/Widow
- Father/Mother
- Grandfathers/Grandmothers
- Sons/Daughters
- Grandsons/Granddaughters
- Brothers/Sisters

Of persons who were or are eligible for membership in the Veterans of Foreign Wars of the United States.

Those eligible for membership in the VFW are those that have received a campaign medal for overseas service; have served 30 consecutive or 60 non-consecutive days in Korea; or have ever received hostile fire or imminent danger pay.

Step- and adopted parents, children, siblings (and half-siblings), grandparents and grand-children are considered the same as biological parents, children, siblings, grandparents and grandchildren and may join the VFW Auxiliary under their VFW-eligible veteran.

Proof of service is required for eligibility and must be obtained by the applicant.





Frequently Asked Questions

- 1. Q.: Every year my Auxiliary participates in a walk in our area that raises awareness about suicide prevention. Members walk in the event and donate \$100 to the organization. Can the number of hours and members who walked in the event count toward Auxiliary Outreach?
 - A.: This is a great team-building activity for your Auxiliary, however, walking or running in an event/race may not be reported under Auxiliary Outreach. This example may be reported under Veterans & Family Support as that's where Veteran & Military Suicide Awareness and Prevention falls.
- Q.: Members of a local Auxiliary were asked to sit on their county board to help raise money and volunteer to work at a dedication of a memorial that honors veterans. Since it was not a VFW- or VFW Auxiliary-sponsored event, can this be reported under Auxiliary Outreach?
 - A.: No, it cannot be reported under Auxiliary Outreach. It's for veterans and the betterment of the community, therefore, it should be reported under Americanism.
- 3. Q.: A few of the ways listed to participate in Auxiliary Outreach involve youth. Wouldn't this be reported under the Auxiliary's Youth Activities Program?
 A.: It depends on the project. For example, if you are putting on a patriotic program at a school with your Auxiliary, that is reported under Americanism and/or Youth Activities. If your Auxiliary volunteers with the Girl Scouts or Boy Scouts to teach them the Folds of the Flag, that is reported under Americanism and/or Youth Activities. If your Auxiliary partners at the Boys & Girls Club to tutor a group of kids, that is reported under Auxiliary Outreach.
- Q.: Our Auxiliary purchases and delivers turkeys for a food pantry every
 Thanksgiving. Does this get reported under Auxiliary Outreach?
 A.: No, it does not. Dropping off turkeys for a Thanksgiving meal is not the same as
 volunteering time in the food pantry organizing food, serving meals, bussing tables,
 etc.
- Q.: Our Auxiliary partners with another organization to host a sock collection at our local Walmart. Does this qualify as Auxiliary Outreach?
 A.: It depends. If you stay and man the collection, then yes. If you drop off a collection bin and leave, then no.

If you are unsure of whether your project for will count toward the Auxiliary Outreach Program, contact your Department Chairman with your questions. the future. So, when Jane went to her monthly meeting, she told her fellow Auxiliary members about the need for volunteers at the blood drive. Her Auxiliary voted to help at these drives. Now when there is a blood drive Jane and other members of her Auxiliary are there, wearing Auxiliary attire and helping. This is Auxiliary Outreach.

VFW Community Service and VFW Auxiliary Outreach

VFW Auxiliary Outreach is similar to the VFW Community Service Program. Below is an excerpt from what the VFW communicates to their Posts. We hope this will help you to know what can and cannot be reported under this Program for both the VFW and the Auxiliary.

VFW Community Service

Community Service as defined by the National Community Service Trust Act "encompasses any human act serving the common good; in the interest of the community." Elsewhere, community service is further defined as "a service that is performed for the benefit of the public or its institutions."

The Veterans of Foreign Wars of the U.S. subscribes to the above but adds that, for the purposes of volunteer recognition, VFW community service must be performed by and as a representative of the Veterans of Foreign Wars and must be performed for an organization outside the VFW and its Auxiliaries and must be verified by an authorized representative of that organization.

In addition, efforts performed for the benefit of the Post or Auxiliary's benefit should not be considered as community service.

A particularly controversial area in VFW community service is service to one's church. Generally, these efforts are not considered community service for two reasons: 1) they are not performed for the community at large; 2) they are part of an individual's service to their faith and not to the VFW. The exception to this would be performing the same service for all religious organizations in a given community.

Important Auxiliary Additions to VFW Community Service:

- Wear something that signifies you are a member of the VFW Auxiliary.
- The project must be voted on during an Auxiliary meeting. (The VFW also requires this in another section of their instructions.)
- If what you are doing is reportable under another Auxiliary Program, report it under that Program, not under Auxiliary Outreach.
- Auxiliary work* (e.g., Outreach, Americanism, Veterans & Family Support, etc.) is to be reported to your local VFW Post Adjutant so it can be added to their report. This will help your Post with eligibility for the National Outstanding Community Service Post Award.
- Auxiliary Outreach volunteer work need not be verified by the organization you are partnering with. (This is a VFW requirement only.)

Auxiliaries are responsible for so many good deeds that help our communities. Collectively, all our projects need to be counted to effectively show the importance of the local VFW and VFW Auxiliary to the community.

We hope this provides clarification on this Program. If you are unsure of whether your project will count toward the Auxiliary Outreach Program, contact your Department Chairman with your questions.

VFW Auxiliary Outreach Guide

What Does and Does Not Qualify



What is Auxiliary Outreach?

Auxiliary Outreach is volunteer work performed by an Auxiliary under the direction of another organization, for the benefit of their community or its institutions. It is a donation of time, not in-kind or monetary donations. It's about partnering with other organizations in our communities to help improve where we live. Auxiliary Outreach can:

- Be performed by people of any age, skill set or ability level.
- Benefit any group of people such as youth, senior citizens and those with disabilities.
- Benefit animals, the environment and public spaces.
- Be done in communities of all types and sizes rural, suburban and urban, small and large.

What's Considered Auxiliary Outreach

Examples include:

- Working walks or runs that benefit other organizations as an event spotter, water station volunteer, timekeeper, etc. (Walking or running in the race is not part of Auxiliary Outreach; that's participation, not partnering.)
- Working with local police on child ID kits or with EMTs to host CPR Training.
- Working with firefighters on fire safety and prevention.
- Working with parks and recreation departments to plant trees, develop non-veteran related community art installations and on adopt-a-park initiatives.
- Helping with a spay and neuter animal clinic.
- Serving food at soup kitchens.

What's Not Considered Auxiliary Outreach

Auxiliary Outreach is for projects NOT AFFILIATED with VFW or VFW Auxiliary Programs. Volunteer work that is performed for the benefit of the Post or Auxiliary is NOT considered Outreach. Examples of projects that do not qualify include:

- Repairs to, maintenance or beautification of the Post home.
- Cooking or serving a meal for a Post or Auxiliary fundraiser.
- "Buddy" Poppy distribution.
- VFW or Auxiliary meetings, conventions, conferences or schools of instruction.
- Providing an honor guard at a member's funeral.
- Flying the American Flag.
- Conducting Flag retirement programs.
- Church activities for one specific congregation and not the entire community (e.g., usher, elder, deacon, minister, etc.)

Examples

- John, an Auxiliary member, mowed his neighbor's lawn out of the goodness of his heart.
 This is not Auxiliary Outreach. John found out his local senior center helps mow lawns for individuals in the community. He brought that up at a meeting. The Auxiliary voted to partner with the senior center. This is Auxiliary Outreach.
- Jane, an Auxiliary member, went to donate blood. She noticed how busy the Red Cross
 volunteers were. She offered to stay to help them, and they accepted. <u>This is not</u>
 Auxiliary Outreach. However, while she was there, she asked if they could use help in

HISTORY

"In Flanders fields the poppies grow / Between the crosses, row on row..."

Thus begins "In Flanders Field", and thus began the strong connection between poppies and military service. It was April 1915 when Colonel John McCrae penned the poem that would be published in Pasch suggestive a few months later. McCrae would not live to see the war's end, but his words have lived on for more than a century.

HISTORY

According to Colobate 75 Years: Ladin
Auxiliary to the VFW, the distribution of elle
popples to benefit children post-war started
as the brainchild Madame Areas Guerin of
France. She weeked closely with the FrancoAmerican Childrens League until 1922, when the

organization was dissolved.

She then connected with the VFW and, by extension, the VFW Auxiliary, to coordinate a nationwide poppy sale ahead of Memorial Day.

In 1923, after a year of struggling to obtain the original silk poppies, a decision was made to purchase materials from an artificial flower shop in New York City. That is also when the decision was made to have the poppies made by disabled seterans and seterans in need, who would be paid for their work.

ANNIVERSARIES

In 2022, the VFW celebrated a century since they declared the poppy the organization's official flower. Because the decision to do so was voted upon during National Convention, 2023 marked one-hundred years of Memorial Day distribution. In February 2024, it will have been 100 years since the name "Buddy" Poppy was registered with the U.S. Patent Office, meaning no other organization can use the name. And in 1955, "Buddy" Poppy officially became a joint Program of the VFW and Auxiliary, providing extra income to disabled veterans, while some of the money from donations goes to the VFW National Home, helping children and families. (The National Home will be celebrating their contennial in 2024)

RECENT & FUTURE CHANGES

COVID-19 meant changes for the "Buddy"# Poppy Program. While members continued to distribute them for

donations outside public establishments, there were few places open in May 2020, making it difficult to do so. In 2023, VFW Headquarters and the VFW Store have been working on the rollout of a new "Buddy" Poppy, one made from tin that is pinched together to be held in place, though the familiar ones will continue to be used. The pundemic also meant changes in who would make and distribute the poppies; this is now done at Cottonwood Incorporated, where adults with developmental disabilities are instrumental in the assembly. This helps them to earn a paycheck while also feeling personal satisfaction, as many are the children and grandchildren of veterans.

The "Buddy"® Poppy has been with us for more than a hundred years, and we hope to continue to use them in remembrance of seterans who have passed, including Colonel McCrae, for another hundred years, thunks to the continued efforts and support of VFW and VFW Auxiliary members.

NATIONAL CONVENTION "BUDDY" POPPY DISPLAY CONTEST

These guidelines have been designed to place emphasis on the purpose and effectiveness of the displays. It is suggested and recommended that Department (State) contests rule be established in a like form.

RULES

(1) Displays will be presented and judged in three categories:

CATEGORY 1.	<u>Public Promotion of Poppy Campaign</u> (Window, booth, parade, poster displays, campaign promotions, etc.)
(a)	Displays must be designed for public exposure and must bear a message soliciting a donation for and wearing of the VFW "Buddy" Poppy.
(b)	At least one (1) of the Poppies used in the display must be in its original form and color, with label attached.
CATEGORY 2.	Memorial or Inspirational Displays (Wreaths, memorial tablets or plaques, patriotic or devotional themes)
(a)	Displays must be designed to honor the dead, to inspire devotion to God and Country, or to dramatize the activities supported by the "Buddy" Poppy.
(b)	At least one (1) of the Poppies used in the display must be in its original form and color, with label attached.
CATEGORY 3.	Artistic or Decorative Use of Poppies (Post Home displays, table center- pieces, corsages, pictures, plaques, models, scenes, hats, novelty pieces, etc.)
(a)	Any display not meeting the qualifications for Categories 1 or 2 shall automatically be entered in Category 3.
(b)	At least one (1) of the Poppies used in the display must be in its original form

and color, with label attached.

- (2) Departments purchasing over 250,000 Poppies will be allowed two (2) displays in each of the three (3) categories for the National Display Contest ... all others will be allowed one (1) display in each of the three (3) categories, no deviations.
- (3) The National Programs Committee shall have no responsibility in setting up, taking down or returning displays.
- (4) Displays shall be set up in space provided in the convention facility. Prior to setting up the display, the responsible person must register with the "Buddy" Poppy desk and complete an entry form (unless one was forwarded earlier, approved by Department) which will show the category of competition, the number of Poppies used, the purpose of the display, the Post and/or Auxiliary number and location, and the name of the person who will dismantle and remove the display at the close of the convention. (Please be advised, all displays must be removed by 4:90 p.m. on Tuesday or it will be disposed of by convention center personnel.)
- (5) Displays <u>may or may not</u> be accompanied by a white card, not to exceed 4 inches by 6 inches in size, on which is lettered in black ink an explanation of the theme for the display or other information of interest to the viewers or the judges.
- (6) Post name, number, city or state (including the shape of your state) may <u>not</u> be visible on the displays. Failure to comply will result in disqualification.

JUDGING

Judging of displays will be on the basis of effectiveness, purpose, clarity of theme, suitability, originality, beauty and number of Poppies used. Where a sample of a large number of identical items (such as corsages or wreaths) is entered, full credit shall be given for the total number of Poppies used. Judging will be completed by Monday evening and the winning displays will have the appropriate ribbons placed on the display.

PRIZES

Plaques will be awarded to the first, second, and third place winners in each of the three categories, and will be mailed to the winning Department's adjutant after convention.

NOTE

The Department adjutant will have to notify the Programs Director, in writing, by <u>June 30th</u> of the Posts that will represent the Department in each category. This will allow us the time necessary to ensure each entry has sufficient space to set up at the National Convention.

Please be advised, the Programs Committee cannot guarantee against theft of personal items placed on the displays. The exhibit hall is secured at night and monitored by security guards: however, they monitor a large area and are not assigned to one specific area. We strongly discourage using items of sentimental value, items of value or items considered to be irreplaceable on the "Buddy" Poppy displays. Thank you and good luck!

VFW Auxiliary Membership Moment

How to Ensure a Membership Application is Complete



One of the most critical steps in considering a new member for the VFW Auxiliary is the careful review of the prospective member's application details by a three-member Investigating Committee appointed by the

Auxiliary President (as outlined in Section 102 of the 2017 VFW Auxiliary Bylaws and Ritual).

As an exclusive veterans' service organization, the VFW Auxiliary must ensure that every prospective

As an exclusive veterans' service organization, the VFW Auxiliary must ensure that every prospective member's eligibility has been thoroughly vetted by an Investigating Committee before any action can be taken on the application. According to Page 1 of the VFW Auxiliary Booklet of Instructions, "it is the duty of the Investigating Committee to see that the applications are filled out completely before they are presented to the body for consideration." The following fields are to be completed on each application:

- Recruited by
- Auxiliary Name and Number
- Kind of Membership (annual, life, etc.)
- State
- Name (spelled correctly)
- · Date of Birth
- Address
- Gender
- · City, State, Zip
- Phone
- E-mail

- · Post Affiliated or Non Affiliated
- Relationship
- · Veteran (name)
- Post Number (if applicable)
- Name of campaign ribbons or medals
- Foreign Service dates
- Location
- · Applicant's signature and date
- Signatures of the Investigating Committee (at least 2)
- · Signature line following the Obligation

in addition to the prospective member's application, it is the responsibility of the investigating Committee to review proof of honorable service of the eligible veteran, unless he/she is a member of the VFW Post to which the applicant is applying for membership.

Proof of the veteran's honorable service in any foreign war, insurrection or expedition (as a member of the U.S. Armed Forces) may be determined through careful examination of a Separation Document (DD214) with a VFW-authorized campaign or service medal of the United States; receipt of Hostile Fire or Imminent Danger Pay, as verified by a copy of a Leave and Earning Statement (LES) issued by the U.S. Armed Forces; or service in Korea for 30 consecutive/60 non-consecutive days after June 30, 1949.


Performance reports, travel orders, medical orders, medals reports, morning reports, assignment listings, buddy affidavits, and letters from a foreign war zone may also be reviewed if a DD214 is not available. For veterans pre-1946, a report of their discharge listing the medals and decorations that were earned is acceptable proof.

For soldiers currently on active duty, they will not have a DD214. In those cases, the appropriate orders showing overseas deployment to a qualifying area, or awarding of an authorized campaign medal, or a LES showing Hostile Fire/Imminent Danger pay will suffice to prove eligibility.
