To begin the Legacy Life Program, the General Operating Investment Fund will lend the Legacy Life Fund \$1,000,000. This will allow the Legacy Life Fund to start earning revenue to pay for initial startup and supply costs. The \$1,000,000 loan would be repaid to the General Operating Investment Fund within five (5) years of the initial transfer to the Legacy Life Fund or when 500 members have become Legacy Life members. The 2026-2027 fiscal year will continue to be a fact-finding year for the Legacy Life Program. A vote for the Legacy Life Program will be held at National President Kim Harney's first Council Meeting following National Convention in August 2027.
